DISCLOSURE OF INTERESTS FORM

FAQ AND USER GUIDE

DOES THIS CONCERN ME?

This concerns all FIA Parties performing a duty for the FIA. The FIA Parties are defined in the preamble to the FIA Code of Ethics as: "FIA and each of its Members, the FIA Administration, the officials appointed by the FIA within its Championships and any persons or organisation belonging in any official capacity whatsoever to FIA or to one of its Members."

Thus, this concerns you if you are an FIA Official, an FIA Consultant, a member of the FIA Administration or a member of one of the Bodies (or Commissions) of the FIA (see appendix, given as an indication).

IS IT AN OBLIGATION?

In the case where the duties are performed for the FIA, it is the responsibility of the FIA Parties concerned to declare their interests using the "FIA Disclosure of Interests Form".

WHAT IF I DO NOT TAKE THIS OBLIGATION INTO ACCOUNT?

The FIA Parties must provide complete and accurate information. Failure to provide disclosure, to update such information in a timely manner or to provide complete information constitutes a **breach of the FIA Code of Ethics**.

WHAT ARE THE POSSIBLE CONSEQUENCES OF A BREACH OF THE FIA CODE OF ETHICS?

A breach of the FIA Code of Ethics can entail the initiation of disciplinary proceedings before the FIA International Tribunal.

WHY IMPLEMENT A DISCLOSURE OF INTERESTS PROCEDURE?

This procedure was established for the sake of transparency and the protection of the FIA Parties.

WHAT ARE THE INTERESTS TO BE DISCLOSED?

Any relationships or matters that may affect, or might be perceived as affecting, your independence carrying out your obligations for the FIA. In case of doubt with regard to the nature of an interest, please disclose it on the form. The non-disclosure of an interest shall constitute a breach of the Code of Ethics, whereas there are no consequences to declaring an interest which, in actual fact, is not one. Please note that the Secretariat of the Ethics Committee is not entitled to provide advice as to the interests which should be disclosed.

WHAT IS A CONFLICT OF INTERESTS?

Conflicts of interest arise if one of the FIA Parties has, or appears to have, private or personal interests that detract from his ability to perform his duties with integrity in an independent and purposeful manner. Private and personal interests include gaining any possible advantage for himself, his immediate family or any person with whom he has a close professional or private relationship.

WHEN SHOULD MY DISCLOSURE FORM BE UPDATED?

The FIA Parties have the ongoing obligation to update their form each time their circumstances change. Failure to update such information in a timely manner or to provide complete information constitutes a breach of the FIA Code of Ethics. Using your login and password, reconnect to your form and use the function "New disclosure as copy" to save you from having to fill in again those fields previously completed.

WHO SHOULD I CONTACT IN CASE OF TECHNICAL DIFFICULTIES?

WHAT HAPPENS TO MY DISCLOSURE FORM ONCE IT HAS BEEN COMPLETED?

The FIA has agreed to establish and maintain a Register of interests for all FIA Parties. It is the FIA Legal Department's responsibility to maintain the Register for the purposes of the FIA Code of Ethics / Ethics Committee. The completed Register will be retained by the Secretariat of the Ethics Committee for a limited period. The Register should not be considered as a substitute for declaring an interest at meetings.

WHO HAS ACCESS TO MY DATA?

The 6 members of the Ethics Committee and the 2 members of the Secretariat of the Ethics Committee only. Of course, you can access your data at any time.

IS THIS ELECTRONIC SYSTEM SECURE?

In order to protect your data, the system used by the FIA is secure and partitioned. Even the IT Department and the helpdesk is not authorised to access the data contained in your form.

Creation of the user account:

Your "user name" generally corresponds to your email address.

If you have already accessed a secure FIA platform (private area, Championship entries, etc.), it is the same account. If you are a member of the FIA Administration, the account is the same as the one used for Intranet.

Forgot password: click on the second link. **Important**: your email address and your password are inseparable! Keep the latter safe.
