1. Michael J. Beloff QC

(United Kingdom)

Michael J. Beloff QC has been a barrister since 1967 and became a Queen's Counsel in 1981. His judicial experience includes time as a Deputy High Court Judge in England and an Appeal Judge in the Channel Islands. He has been a member of the Court of Arbitration for Sport and has sat on over 100 cases since 1996. He has been Chairman of the International Cricket Council's Code of Conduct Commission since 2002 and President of the British Association for Sport and Law since 2006.
