Licence for Officials

The FIA is willing to establish a licensing system of its own international officials and to encourage the ASNs to issue licences for their own officials using the tool that the FIA will make available to them – most probably on an online platform (which will be discussed during the **Workshop 2 on Wednesday afternoon**).

For those ASNs already issuing licences to their officials, the aim is to encourage the use of the above tool, which will bring together the various national systems in a single platform and format.

Objectives of this project:

One of the main objectives is to have all ASNs using the same terminology and to have the same definition around the world for each term (for instance, for each role of an official). This will facilitate the possible participation of foreign officials in an event and will allow more efficient exchanges among ASNs, and between the FIA and the ASNs (guidelines, e-learning, seminars, etc.).

By speaking the same language, we can progress together.

In a broader perspective, the FIA is planning to create a website for ASNs that they can use to manage their officials. Each ASN would manage its own microsite; part of it would be public access, and part of it restricted access (up to the ASN).

We have identified the following roles for which a licence should be issued:
