

## International Tribunal Successful Candidate Biographies

1. Laurent Anselmi  
(Monaco)

Laurent Anselmi is an experienced lawyer who has occupied the post of Counsel to the Cabinet of His Serene Highness the Sovereign Prince of Monaco. He is presently Delegate for Legal affairs before the Princely Government. He has been a deputy member of the FIA's International Court of Appeal since 2004. He is also an adjunct professor at the International University of Monaco and a representative of the Principality at the Committee for International Law of the U.N.O.

2. Didier Louis Bollecker
