Clarification Note N°4 – to all FIA F3 European Championship Competitors

Geneva, 01 April 2014

Dear Competitors,

Please find bellow a clarification regarding Article 22.6 of the Sporting Regulations (Track Testing)

"No more than two sets of new dry-weather tyres and one set of new wet-weather tyres, provided on site by the designated tyre supplier, may be used by each car during each day of official track testing. In addition to the above, tyres registered at previous Events or official test days may also be used."

As an option: For the OFFICIAL TEST DAYS ONLY it will be permitted to re-register new wet tyres purchased from the designated tyre supplier in 2013 in replacement of the on-site allocated tyres for testing. No more than 1 new set of wet weather tyres is permitted for each day of testing.
