Dear Competitors,

We are pleased to inform you that:

1. The Sporting Regulations of the FIA European Touring Car Cup will be soon available on the website www.fia.com or via the following link:

2. Calendar:

Please find attached the calendar approved by the WMSC of 3 December 2014.

3. The online entry form (<http://entryforms.fia.com/web/registrationetcc.nsf>) are available from **Monday, 26 January 2015**. You may apply to enter after reading the conditions for entry described in Article 37 of the applicable sporting regulations.

a) Cost of entry per Season:

- 24,300 € per car for the Super 2000 category (TC2 Turbo)
- 18,800 € per car for the Super 2000 (TC2-2010), TCN and Single Make categories
- 9,400 € per car for the Super 1600 category

➡ Closing date: **31 March 2015**

b) Cost of "Race-by-race" entries:

- 5,060 € per Event per car for the Super 2000 category (TC2 Turbo)
- 4,350 € per Event per car for the Super 2000 (TC2-2010), TCN and Single Make categories
- 2,170 € per Event per car for the Super 1600 category

➡ Closing date: **14 days prior to the beginning of the event.**

Attachments which must IMPERATIVELY accompany the entry application:

- a copy of the competitor's licence issued by the ASN
- a copy of the driver's licence
- a copy of the first page of the homologation form of the car, as issued by the ASN or the FIA (featuring the homologation number)
- a certificate from the ASN concerned proving that the car conforms to the national technical regulations
- a copy of the bank transfer voucher corresponding to the amount of the entry fees required



4. Eligibility of cars

In accordance with Article 10. d) of the applicable sporting regulations concerning the eligibility of cars conforming to the technical regulations of a national championship, we ask you to send the **attached form**, duly completed, to committee.tc@fia.com before the closing date.

5. Billing information

We kindly draw your attention to carefully indicate your billing address at the time of inscription. This address will be used for issuing invoices for payments related to your entry fee and fines. Once the invoice has been emitted, there may be no further changes in the billing address information.
