2025 FIA GENERAL ASSEMBLIES

NOTE EXPLAINING THE PROCEDURE FOR SUBMITTING CANDIDATURES FOR THE PRESIDENTIAL LIST AND FOR THE WORLD COUNCILS

This note aims to provide guidance regarding the submission of candidatures for the Presidential List and for the World Councils in accordance with the FIA Statutes and Internal Regulations (https://www.fia.com/fia-statutes-and-internal-regulations). This information and other related documents can be found on the FIA website: https://www.fia.com/2025-elections.

A. PRESIDENTIAL LIST

The Presidential List includes the President of the FIA (standing as the leader of the list), the President of the Senate, the Deputy President for Automobile Mobility and Tourism, the Deputy President for Sport and the seven (7) Vice-Presidents for Sport.

In order to be eligible:

- a) a candidate for the presidency of the FIA must submit a complete list to the FIA Administration (at the following email address: elections@fia.com), including all supporting documents referred to in item b) below, duly completed and signed no earlier than 3 October and no later than 24 October 2025.
- b) the list to be submitted by the candidate for the presidency of the FIA shall:
 - include the full names and positions for each of the candidates included in the Presidential List, as set out in FORM A1 attached, also available on the FIA website: https://www.fia.com/presidential-list.

For the position of Vice-President for Sport, the list will include the names of candidates from among those proposed by FIA Members for the World Motor Sport Council (WMSC) as follows:

- one (1) candidate from Middle East and North Africa (Algeria, Egypt, Libya, Morocco, Mauritania, Sudan and Tunisia);
- one (1) candidate from Africa (with the exception of Algeria, Egypt, Libya, Morocco, Mauritania, Sudan and Tunisia);
- o one (1) candidate from North America;
- o one (1) candidate from South America;
- o one (1) candidate from Asia-Pacific; and
- o two (2) candidates from Europe.

The names of the candidates for the WMSC will be communicated to any person intending to submit a Presidential List, as of 16 September 2025.

- be accompanied by:
 - an acceptance of mandate from each candidate included in the Presidential List and written declaration of support from the FIA Member to which the candidate for the Presidential List belongs (the latter requirement shall not apply to the candidate for the presidency of the FIA), as set out in FORM A2 attached, also available on the FIA website: https://www.fia.com/presidential-list;
 - the CVs/resumes and a copy of the ID document of each candidate included in the Presidential List;
 - a confidentiality and non-disclosure undertaking duly completed and signed by each
 of the candidates included in the Presidential List (this document will be provided
 upon request to <u>elections@fia.com</u>); and
 - an FIA Disclosure of Interests Form duly completed and signed by each of the candidates included in the Presidential List (this document will be provided upon request to <u>elections@fia.com</u>).

FEDERATION INTERNATIONALE DE L'AUTOMOBILE

- satisfy the following three (3) cumulative conditions:
 - o have the support of at least six (6) ACNs;
 - o have the support of at least six (6) Mobility Members; and
 - o have the support of at least six (6) ASNs.

It shall be noted that:

- o only FIA Full Members that are not being subject to a suspension measure shall be entitled to support a Presidential List; and
- o an FIA Full Member may only support one (1) Presidential List.

This support must be provided using FORM A3 attached, also available on the FIA website: https://www.fia.com/presidential-list).

- c) each candidate included in the Presidential List must comply with the age limit requirements set out in the FIA Statutes, namely:
 - the candidates for the positions of President of the FIA, President of the Senate, Deputy President for Automobile Mobility and Tourism and Deputy President for Sport must be under 70 years of age on the day of the election (or of the re-election), i.e. on 12 December 2025; and
 - the candidates for the position of Vice-President for Sport must be under 75 years of age on the day of the election (or of the reelection), i.e. on 12 December 2025.
- d) there must not be anything in the record of each candidate included in the Presidential List that calls into question their professional integrity.
- e) candidates for the positions of President of the FIA, President of the Senate, Deputy President for Automobile Mobility and Tourism and Deputy President for Sport must not have performed three terms of office, whether consecutive or not, in the same position.
- f) a list cannot include a candidate who is already entered on another Presidential List and the mixing of names from different lists is prohibited. In such event:
 - the FIA Administration will inform the candidate for the presidency of the FIA concerned that the said candidate will be *ipso facto* ineligible; and
 - the candidate for the presidency of the FIA concerned will need to provide a replacement for this ineligible candidate as soon as possible and at latest within the seven (7) days following the date of the information of the FIA Administration and in any event before 12 December 2025.
- g) one and the same person cannot:
 - hold the positions of Vice-President for Sport and Vice-President for Automobile Mobility and Tourism at the same time; and
 - hold the positions of Deputy President for Automobile Mobility and Tourism and Vice-President for Automobile Mobility and Tourism at the same time.

B. WORLD MOTOR SPORT COUNCIL

The World Motor Sport Council (WMSC) is composed of the President of the FIA, the Deputy President for Sport, seven (7) Vice-Presidents for Sport, fourteen (14) members elected by the General Assembly and five (5) members by right.

In addition to the President of the FIA, the Deputy President for Sport and the seven (7) Vice-Presidents for Sport who are included in the Presidential List, fourteen (14) seats on the WMSC are to be filled.

In order to be eligible:

- candidates for the WMSC must be under 75 years of age on the day of the election (or of the re-election), i.e. on 12 December 2025;
- there must not be anything in the record of each of the candidates for the WMSC that calls into question their professional integrity;
- candidates must sign a confidentiality and non-disclosure undertaking (this document will be provided upon request to <u>elections@fia.com</u>); and
- candidates must sign an FIA Disclosure of Interests Form (this document will be provided upon request to <u>elections@fia.com</u>).

Only the FIA Full Members holding the sporting power (Articles 3.1 and 3.3 of the FIA Statutes), having at least one (1) competition entered on the 2025 International Sporting Calendar and not being subject to a suspension measure are invited to propose candidates.

FIA Members complying with these requirements must submit the name of the candidates for the position of member of the WMSC and any supporting documents required, as set out on the form provided for this purpose (FORM B attached, also available on the FIA website: https://www.fia.com/election-world-motor-sport-council-members).

The form duly completed and signed together with the supporting documents, must be sent to the FIA Administration (at the following email address: elections@fia.com) no later than 16 September 2025.

As a reminder, the WMSC:

- shall include at least three (3) members of each gender from among the seven (7) Vice-Presidents for Sport and the fourteen (14) elected members; and
- shall not include more than two members of the same nationality from among the seven (7)
 Vice-Presidents for Sport and the fourteen (14) elected members.

C. WORLD COUNCIL FOR AUTOMOBILE MOBILITY AND TOURISM

The World Council for Automobile Mobility and Tourism (WCAMT) is composed of the President of the FIA, the Deputy President for Automobile Mobility and Tourism, six (6) Vice-Presidents and eighteen (18) members elected by the General Assembly.

In addition to the President of the FIA and the Deputy President for Automobile Mobility and Tourism who are included in the Presidential List, six (6) Vice-Presidents and eighteen (18) seats on the WCAMT, representing the four (4) Automobile Mobility and Tourism Regions, are to be filled.

Each of the Automobile Mobility and Tourism Regions must submit the name of the candidates for the position of member of the WCAMT and any supporting documents required, as set out in FORM C attached, also available on the FIA website: https://www.fia.com/election-world-council-automobile-mobility-and-tourism-members):

- Region I: three (3) Vice-Presidents (namely the elected President of Region I and two (2) other Vice-Presidents representing the Region I's subdivisions to which the President of Region I does not belong) as well as eight (8) other members;
- Region II: one (1) Vice-President (namely the elected President of Region II) and five (5) other members;
- Region III: one (1) Vice-President (namely the elected President of Region III) and two (2) other members;
- Region IV: one (1) Vice-President (namely the elected President of Region IV) and three (3) other members.

In order to be eligible:

- candidates for the WCAMT must be under 75 years of age on the day of the election (or of the re-election), i.e. on 12 December 2025;
- candidates shall represent one of the four (4) Automobile Mobility and Tourism Regions;
- candidates shall be supported by an FIA Full Member with Mobility competence (Articles 3.1 and 3.2 of the FIA Statutes) that is not being subject to a suspension measure;
- candidates shall be of different nationalities, save for the President of the FIA and the Deputy President for Automobile Mobility and Tourism;
- there must not be anything in the record of each of the candidates for the WCAMT that calls into question their professional integrity;
- candidates must sign a confidentiality and non-disclosure undertaking (this document will be provided upon request to <u>elections@fia.com</u>); and
- candidates must sign an FIA Disclosure of Interests Form (this document will be provided upon request to <u>elections@fia.com</u>).

The form duly completed and signed together with the supporting documents, must be sent to the FIA Administration (at the following email address: elections@fia.com) no later than 17 October 2025.
