

### **Elections Guidelines**

These Elections Guidelines are issued ahead of the elections that will take place during the FIA General Assemblies on Friday 12 December 2025 in Tashkent (Uzbekistan).

They contain details regarding the procedures which will be followed in accordance with the FIA Statutes and Internal Regulations available at <a href="http://www.fia.com/fia-statutes-and-internal-regulations">http://www.fia.com/fia-statutes-and-internal-regulations</a> as well as other useful information.

The content of these Guidelines is to be read in accordance with the FIA Statutes and Internal Regulations. In the event of any conflict or discrepancy, the FIA Statutes and Internal Regulations will prevail over these Guidelines.

### **Elections covered by these Guidelines**

These Guidelines cover the following elections that will take place during the FIA General Assemblies:

- the Presidential List;
- members of the World Motor Sport Council (WMSC); and
- members of the World Council for Automobile Mobility and Tourism (WCAMT).

Additional information will be provided for the elections of the members of the Senate which will take place after the FIA General Assemblies.

These Guidelines do not cover other elections that will take place during these FIA General Assemblies, such as the election of the members of the International Tribunal and International Court of Appeal, or the election of the members of the Anti-Doping Disciplinary Committee.

## **Presidential List**

### **Process and key dates**

- As of 19 September 2025, following closure of the deadline to submit candidatures for the WMSC, the candidates for the WMSC proposed by ACNs, ASNs and the Senate, may be available to any person intending to submit a Presidential List.
- <u>Between 3 and 24 October 2025</u>, candidates for the presidency of the FIA must submit a Presidential List together with all required documents.
- November 2025, the Nominations Committee will examine the compliance of the Presidential List(s) with the eligibility criteria and submit the List(s) meeting these criteria to the General Assembly for election.
- 12 December 2025, the General Assembly will elect the Presidential List for a 4-year term of
  office.



### **World Motor Sport Council (WMSC)**

# Composition of the WMSC



### Process and key dates

- 19 September 2025, deadline to submit candidatures for the WMSC.
- <u>Between mid-September and October 2025</u>, the Nominations Committee will examine the compliance of the candidatures for the WMSC with the eligibility criteria and submit the candidatures meeting these criteria to the General Assembly for election.
- 12 December 2025, the General Assembly will elect, for a 4-year term of office, the Presidential List (which includes the President of the FIA, the Deputy President for Sport and 7 Vice-Presidents for Sport among others) and 14 members for the WMSC.



### World Council for Automobile Mobility and Tourism (WCAMT)



#### **Process and key dates**

- 17 October 2025, deadline to submit candidatures for the WCAMT.
- <u>November 2025</u>, the Nominations Committee will examine the compliance of the candidatures for the WCAMT with the eligibility criteria and submit the candidatures meeting these criteria to the General Assembly for election.
- <u>12 December 2025</u>, the General Assembly will elect, for a 4-year term of office, the Presidential List (which includes the President of the FIA and the Deputy President for Automobile Mobility and Tourism among others) and 18 members for the WCAMT.

### **Election campaign**

### **Conduct during the election campaign**

Promotion of a candidate shall be conducted with dignity and moderation, in compliance with the FIA Statutes, the FIA Internal Regulations and the FIA Code of Ethics.

In promoting their candidacy, each candidate, or any person involved in their candidacy, must:

- · respect other candidates.
- · abide by the highest standards of ethical behaviour.
- not be the source of any words, writings or representations likely to tarnish the image of another candidate or to prejudice them in any way.
- take all reasonable and necessary steps to ensure the neutrality of the FIA Administration in all matters relating to the FIA elections.
- not organise events and/or promotional activities related to their campaign within the FIA's and/or the FIA bodies' events.

For candidates who already are exercising a role within the FIA and/or its bodies, they must ensure that their personal interests do not interfere with the proper exercise of their role within the FIA and/or its bodies.

### **Recommendations of the Ethics Committee**

Candidates are invited to get acquainted with the <u>Recommendations of the Ethics Committee in view of the Presidential Elections</u> and to fully comply with them.

### **Neutrality of the FIA Administration**

During the election campaign period, the FIA Administration continues to carry out its activities as usual while respecting the following:

- limit the relations with candidates for the FIA's presidency to the strictly necessary, i.e. as required by the nature of their role and their mission;
- respect the principle of neutrality in all matters relating to the elections;
- respect the principle of equal treatment between candidates for the FIA's presidency;
- not use the resources of the FIA for the benefit and/or promotion of a candidate for the FIA's presidency;
- refrain from making any public declaration in support of any of the candidates for the FIA's presidency in any way; and
- refrain from endorsing and/or supporting a candidate on social media (e.g. through shares, likes, retweets, reposts) both on professional (if any) and personal accounts.

These requirements apply to the members of the FIA Administration (General Manager, directors, employees, trainees) and third parties contractually engaged with the FIA (e.g. consultants).
