Full description of the request

Request(s):

To provide a waiver for the design of the VOLVO S60 WTCC VK-S2000 "Engine of the make" 1.6T engine block top deck gasket until 2016-12-31.

Reason(s):

Following the FIA Homologation Inspection of the VOLVO S60 WTCC VK-S2000 vehicle and 1.6T engine and subsequent confirmation of non-compliance of the top deck gasket, we are unable to present a solution to substitute for the part concerned in time for the beginning of the 2016 season. The part has no influence on engine power or torque therefore providing no competitive advantage and it will not be possible to compete until a solution has been brought forward. Any subsequent redesign will arrive late in the 2016 season, affecting the majority of the 2016 season and compromising the design process of the 1.6T engine for the next 3-year homologation period beginning 1st January 2017. At no point during the homologation process have we sought to withhold that we will utilize this solution and were notified first of its non-compliance at the FIA homologation inspection, therefore we would like to request a waiver for the design of the top deck gasket until 2016-12-31.
