WITH REFERENCE TO ART. 5.2 OF HOMOLOGATION REGULATIONS FOR 1.6 TURBO ENGINE, IT IS REQUESTED THAT "ALL JOKERS HOMOLOGATED DURING ONE PREVIOUS CALENDAR YEAR MUST MAY BE USED SIMULTANEOUSLY"

Homologation joker :

Our HONDA CIVIC WTCC according to the previous cycle homologation (2014-2016) is still eligible. However, the Technical Regulations oblige us to update our car to the latest 2016 specification, we are to request the eligibility of the car without the non-mandatory parts from 2016. These are the followings:

- Chassis reinforcement and modification (A-5747 214/11 ER)
  - o Rear wheel arch reinforcement
  - o Rear ARB reinforcement
  - o Rear subframe fixation reinforcement
  - o Flat floor fixation bushes



- Front subframe (A-5747 214/11 ER)
- Steering rack fixation to 2016 front subframe and stiffening
- 2016 spec dampers
- Radiator mounting bracket
- Exhaust pipes (A-5747 214/11 ER)
  - o 2016 homologated exhaust manifold
  - o 2016 downpipe (new material)
- Lubrication system new oil hose from oil tank to heat exchanger
- Fuel tank upgrade (new lifting pump and filter system)
- Bodywork parts:
  - o Front end bulkhead modification
  - o Bonnet new plybook composite material stack
  - o New H2O radiator cooling inlet design

However the car would be operated without the non-mandatory parts from 2016 all the compulsory modifications from 2017 concerning safety (lifting device, seat belt) will be installed.
