## 2018 FIA EUROPEAN TRUCK RACING CHAMPIONSHIP

Information note dated **24 January 2018** for all potential entrants regarding the ETRC entries

Dear Competitors,

We hereby remind you that Championship's registrations can **only be made by means of electronic form**  
*WARNING: The passwords allocated in 2017 remain valid for 2018.*

### a) "Season" competitors' entries:

- o Closing date: ..... **26 April 2018, midnight.**
- o Entry fee: ..... **4700 Euros** per truck per season.

We remind you that all **"full-season" entries** must be made before **26 April 2018, midnight.**

All entries must be approved by the FIA before becoming valid.

From the date of this approval, all entry fees become due. In case of refusal of the entry, you will be contacted personally.

### b) "Race-by-race" competitors' entries:

- o Closing date: ..... **14 days before the start of the event in question.**
- o Entry fee: ..... **1200 Euros** per truck per event.

We remind you that any competitor wishing to enter on a **"race by race"** basis may do so via the link given above as from **Wednesday 24 January 2018** and just up to the **2 weeks before start of the Event** concerned. All to be done is to select the event(s) in the calendar which is proposed at the 1<sup>st</sup> step of the online entry procedure and pay the corresponding amount.

Before entering an entry for yourself or your team, the entrant must ascertain by checking with the FIA that the **truck model concerned is considered eligible** according to the terms of Article 2) of the present regulations. The Truck Racing Commission's Technical Working Group has the ability to request, if necessary, additional information before the entry is accepted. Moreover, we kindly ask you to **provide all the items listed below**, without which you will not be able to register:

We also would like to point out that, as in 2017, you have the possibility to enter a **second driver**, called "**reserve driver**" on condition that you explicitly mention him in Appendix 1 (attached) for the chosen events.

Furthermore, this Appendix shall also be used to declare **absences** (see Article 6.4 of the applicable Sporting Regulations). We would like to underline the importance to entering a correct billing address when registering your entry form. The entered billing address will be used throughout the whole season for any invoices regarding the inscription as well as for any eventual fines.

#### **4. 2018 EUROPEAN CHAMPION TITLE FOR TEAMS:**

We hereby remind you that, since 2007, the Championship offers you the possibility to register for the FIA European Truck Racing Champion Team's title (see Article 4.2 and 6.1.2 of the applicable Sporting Regulations).

Please provide us with the name of your Team, together with the names of the 2 drivers participating in this Championship at the moment of this registration.

**Each entry will be regarded as valid only if it has been duly filled in, and if the necessary documents listed above have been provided and the bank transfer has appeared in the FIA accounts before the closing date for entries.**

**Extract Art. 6.4:** «A competitor entered for the season may nominate, in addition to the main driver, a **reserve driver** at the time of his entry for any truck he enters. **The list of Events in which the reserve driver will take part must be attached to the entry form.** Any competitor will have the opportunity to declare a change between the main driver and the reserve driver up to the closing date for entries in the Competition concerned. A driver change may also be authorised at a Competition before the end of scrutineering, only in cases of “force majeure” recognised as such by the Panel of Stewards. The reserve driver or the replacement driver in a case of “force majeure” will be authorised to score points in the Championship, but these cannot be cumulated with the ones scored by the replaced driver. »

**Important:** Competitors entered in the Championship are required to participate in all of the Events counting towards the Championship. If this is not the case, the competitor must indicate this on the form.

« **A maximum of 1 Event** may be mentioned in this prior notice if the Championship comprises a total of 10 Events. Any competitor who does not participate in a Competition that is not included in the prior notice will be liable to a fine of 3000 euros from the 1st infringement, and from the 2nd infringement may be excluded from the Championship for the rest of the season» (Art. 6.1.7).
