### Entry applications must imperatively be accompanied by the following attachments:

- Confirmation that the applicant has read and understood the Code, the Technical Regulations, and the Sporting Regulations and agrees to them;
- a colour photocopy of the competitor's licence and driver's licence issued by the respective ASNs;
- a copy of the 1<sup>st</sup> page of the Technical form of the race car issued by WSC Ltd and the WTCR Technical passport issued by the FIA (on which the Homologation number appears);
- a certificate that certifies the servicing and updating of the data acquisition system, if required (cf. Article 60 a)-A of these regulations); and
- a copy of the bank transfer corresponding to the total amount of the entry fee required

#### **NOTE**

We would like to underline the importance to entering a correct **billing address** when registering your entry form. The entered billing address will be used throughout the whole season for any invoices regarding the inscription as well as for any eventual fines.

You are requested to inform the FIA administration of any changes related to your season inscription (drive change, withdrawal, etc.) of your entrant at least 48 hours before the beginning of a competition. Any changes after this deadline will be validated at the Stewards' discretion.
