<sup>&</sup>quot;12.12.1 A sentence of Suspension pronounced by an ASN shall apply only within the territory of that ASN.

<sup>12.12.2</sup> If, however, the <u>ASN wishes the sentence of Suspension to be recognised internationally</u>, it shall notify its wish without delay to the Secretariat of the FIA and the latter will inform all other ASNs. The sentence of Suspension shall be noted by each ASN immediately, and the consequent restriction will thereby come into force.

<sup>&</sup>quot;12.13.1 Except in the cases provided for in the FIA Judicial and Disciplinary Rules, a sentence of Exclusion can be <u>pronounced only by an ASN</u>, and will be reserved for offences of exceptional gravity. 12.13.2 A sentence of Exclusion shall always be international in nature. It shall be notified to all the ASNs, and be registered by them according to the conditions of international Suspension."
