




Within the framework of the FIA European Rallycross Championship, it is the FIA administration that manages your entry. Consequently, we would like to draw your attention to the fact that all new information regarding, and any amendments to, your entry must be communicated to the FIA Off-Road Department.

In order to clarify the application process, please find below a few essential points of which you must be aware.

REGISTRATION

- ✓ Applications to participate in the Championship or in a Competition of the Championship shall be submitted to the FIA by means of the entry form available on the following link: https://registrations.fia.com/europeanrx.
- ✓ Applications that have not been submitted online and/or after the closing date of entries for the competition concerned will be refused.
- ✓ <u>Identification to the new registration website 2019 Season</u>:
 - 1. If you have not made an online entry to at least one Rallycross World or European Championship competition in previous seasons, please <u>request a password</u>.
 - 2. If you have already made an online entry to at least one Rallycross World or European Championship competition in previous seasons but:
 - you have changed email address \rightarrow please follow procedure n°1.
 - you have forgotten your password → <u>please click on "Forgot password" in order to reset it.</u>
 - if you have neither changed your email address, nor forgotten your password → please use the same password.
- ✓ When submitting an entry, the Competitor and/or Driver <u>must</u> provide:
 - copies of the Competitor's and Driver's Licences,
 - a copy of the duly signed entry form (that must also be sent by post),
 - the entry fee to the order of the FIA, either by bank transfer of Credit Card (for every payment made by bank transfer, do not forget to provide proof of payment delivered by your bank).
- → Only dossiers respecting the above requirements, and which are complete, will be taken into consideration.




SUPERCAR CATEGORY

- ✓ Drivers must hold a <u>valid international</u> Driver's and Competitor's licences with a <u>grade C</u> <u>as a minimum</u>, and the necessary authorisations (visas) issued by their ASNs affiliated to the FIA. Each Driver holding a licence of a grade <u>other than A, B or C will not be authorised to compete</u>, unless she/he requests a change of grade from her/his ASN and provides a copy of this new licence from the FIA Off-Road Department within the deadline. The name of the Driver appearing on the entry lists will be the name of the person declared on the licence.
- ✓ Each Competitor must hold <u>valid international</u> Competitor's licence issued by an ASN. The name of the Competitor appearing on the entry lists will be the name of the entity or person declared on the licence.

SUPER 1600 CATEGORY

- ✓ Drivers must hold <u>valid international</u> Driver's and Competitor's licences with a <u>grade D as a minimum</u>, and the necessary authorisations (visas) issued by their ASNs affiliated to the FIA. Each Driver holding a licence of a grade <u>other than A, B, C or D will not be authorised to compete</u>, unless she/he requests a change of grade from her/his ASN and provides a copy of this new licence from the FIA Off-Road Department within the deadline. The name of the Driver appearing on the entry lists will be the name of the person declared on the licence.
- ✓ Each Competitor must hold <u>valid international</u> Competitor's licence issued by an ASN. The name of the Competitor appearing on the entry lists will be the name of the entity or person declared on the licence.





2019 FIA EUROPEAN RALLYCROSS CHAMPIONSHIP FOR SUPERCARS



In accordance with articles 9.4 and 9.5 of the Sporting Regulations of the 2019 FIA European Rallycross Championship, applications to participate in the Championship must be submitted to the FIA as follows:

Permanent entries

- → The closing date to enter <u>all</u> Championship Competitions is set at 07 March 2019 (midnight, Swiss time);
- \rightarrow The entry fee per Driver for <u>all</u> the Championship Competitions is £9,000 in Supercar (one single payment).

• Non-permanent entries

- → Applications to enter <u>one single</u> Competition or <u>on a Competition-by-Competition basis</u> must be submitted at least 28 days prior to the Competition concerned (see table below);
- \rightarrow The entry fee per Driver for one Championship Competition is £1,500 in Supercar
- → If entry applications received within the time limits exceed the maximum number of entries set for the Competition in question (see table below), applications will be selected according to the criteria set in Article 9.7 of the European Rallycross Championship Sporting Regulations.

2019 FIA EUROPEAN RALLYCROSS CHAMPIONSHIP FOR SUPER 1600

In accordance with articles 9.4 and 9.5 of the Sporting Regulations of the 2017 FIA European Rallycross Championship, applications to participate in the Championship must be submitted to the FIA as follows:

Permanent entries

- → The closing date to enter all Championship Competitions is set at 07 March 2019 (midnight, Swiss time);
- \rightarrow The entry fee per Driver for <u>all</u> the Championship Competitions is £3,000 in Super 1600 (one single payment).

• Non-permanent entries

- → Applications to enter <u>one single</u> Competition or <u>on a Competition-by-Competition basis</u> must be submitted at least 28 days prior to the Competition concerned (see table below);
- → The entry fee per Driver for one Championship Competition is £500 in Super 1600.
- → If entry applications received within the time limits exceed the maximum number of entries set for the Competition in question (see table below), applications will be selected according to the criterias set in Article 9.7 of the European Rallycross Championship Sporting Regulations.

ENTRIES LIMITATIONS AND SELECTION CRITERIA



By agreement with the Championship promoter and the FIA, an organiser can set a maximum number of entries lower than 40 for the Competition, subject to this limitation being communicated when application opens and written in the Supplementary Regulations.

If entry applications received within the time limits exceed the maximum number of entries set for the Competition in question (see table below), entries will be selected and validated according to the following order of priority:

Priority 1: Drivers entered as or by the permanent individual Competitors registered in the Supercar Championship, as well as Drivers having entered the Super1600 Championship as permanent Drivers;

Priority 2: Non-permanent Drivers who have scored the most Championship points in previous Competitions of the present season;

Priority 3: Non-permanent Drivers having taken part in all the Competitions in the World Championship or in a European Rallycross Championship the previous year;

Priority 4: Non-permanent Drivers who have taken part in previous Championship Competitions of the present season;

Priority 5 (Supercar only): Championship Promoter proposed entry as a «Wild Card» (at the discretion of the Championship Committee);

Priority 6: All other entries will be selected according to the order in which they reach the FIA secretariat;

Priority 7 (Super 1600 only): Drivers stripped of their "permanent" status who have scored the most Championship points in previous Competitions of the present season;

Priority 8 (Super 1600 only): Drivers stripped of their «permanent» status who have taken part in previous Championship Competitions of the present season;

Priority 9 (Super 1600 only): all the other Drivers stripped of their «permanent» status will be selected according to the order in which their entry application reached the FIA secretariat.

In addition, please note that Drivers who are not selected on the basis of the abovementioned priorities will be entered on a <u>reserve list</u>. Thus, if a pre-selected Driver withdraws his entry before the Monday (noon) preceding the relevant Competition, the first Driver on the reserve list will be offered the vacant place. If no reply is received within 24 hours following the proposal or if the latter turns down the place, the next Driver on the same list will be offered the vacant place and so forth.


The replacement of one or several Driver(s) who have withdrawn with Drivers from the reserve list may be carried out up until Monday noon before the relevant Competition.
