(2) Absolute Maximum Petrol Flow. Actual Petrol Flow limit is function of engine speed according to registered engine datasheet.

(3) A stint will be considered from pit-out to pit-in, including laps prior to the start of the race (last reconnaissance and formation laps) and after the race checkered flag up to Parc Fermé (cooling laps).

At the request of the Endurance Commission, please note that this EOT features the changes listed below:

- A 26 kg increase in weight for LMP1H;
- A target number of laps per stint increased by 2 for LMP1NH, equaling the target number of laps per stint of LMP1H.

These changes were only possible thanks to the agreement of the LMP1H competitor, as the Technical/Sporting Regulations and Decision 18-D0001 imposes that:

- "no adjustment will be requested to the Hybrid of reference";
- A number of laps per stint different by 2 laps for WEC events.
