Decision: To disqualify Competitor ACCR Czech Team Liqui Moly repesented by Rybnicek Marek, car No 7, Driver Mr. Rybnicek Marek form the Round 10 of FIA EHC in Saint-Ursanne -Les Rangiers (CHE), and decided that all drivers who are classified below him in the Classification of Round 10 of FIA EHC in Saint-Ursanne - Les Rangiers (CHE) will be moved up 1 place.

Reason: According the art 11.1 and 15.7.d of of Sporting Regulations the FIA Europen Hill-Climb Championship 2019 the Gasoline should be all the time during the Competition in accordance

with the Art. 252.9 of Appendix J, FIA ISC.
