

2025 FIA TCR WORLD RANKING FINAL

REGISTRATION PROCESS





DEAR DRIVERS & COMPETITORS,

We sincerely appreciate your interest in the inaugural **2025 FIA TCR World Ranking Final**, organised in close partnership between the FIA and WSC Group.

This prestigious event will be held at the **Autodromo Piero Taruffi Vallelunga from 21 to 23 November, 2025.** Spanning three action-packed days, this exclusive competition will feature top drivers from around the world, selected based on their performance in the TCR World Ranking.

Registrations are open from 1 July until 30 October 2025 (12:00 CET).

We encourage you to carefully review the detailed information provided in this document and to submit your registration for this landmark occasion.

1. ELIGIBLE DRIVERS AND COMPETITORS

Each competitor may enter one main driver per one car, accompanied by a guest driver. To be eligible, main drivers must appear in the 2025 TCR World Ranking as of 6 October 2025. Guest drivers can be any drivers with a minimum of ITD-C license. Drivers competing full-time in the Kumho FIA TCR World Tour are not eligible to enter as main drivers, though they may be registered as guest drivers. A maximum of 60 main driver entries will be accepted for the event.

2. COMPETITION FORMAT

FORMAT A: Up to 35 entries (2-day event)

Two 45-minute free practice sessions

One 30-minute final qualifying session

One Qualifying Race of 55 min + 1 lap

One Main Race of minimum 65 km

FORMAT B: 36 to 60 entries (3- day event, min 2 groups, max 3 groups)

First Phase - Play-offs:

One 45-minute free practice session, per group

One 20-minute Play-off Qualifying session

Play-off Race of 20 min + 1 lap (one race in case of two groups, two races in case of three groups)

Final Phase:

The Play-Off system will identify 30 drivers who will be allowed to proceed to the following stage, which will consist of:

Final 30-minute qualifying session

Qualifying Race of 55 min + 1 lap

Main Race of a minimum 65 km



3. FIA REGULATIONS

The Competition will be run according to the 2025 FIA TCR World Ranking Final - Sporting Regulations and 2025 FIA TCR World Ranking Final - Technical Regulations which are available on the FIA website:

4. WORLD RANKING FINAL TITLES

The title of 2025 Kumho FIA TCR World Ranking Final – Winning Driver will be awarded to the MAIN driver who has finished the Main Race in first position.

The title of 2025 Kumho FIA TCR World Ranking Final — Winning Team will be awarded to the competitor of the winning driver.

5. REGISTRATION PERIOD

OPENING OF REGISTRATIONS:

1st of July 2025 (12:00 CET)

CLOSING OF REGISTRATIONS:

30th of October 2025 (12:00 CET)

OFFICIAL ENTRY LIST ANNOUNCEMENT:

The FIA entry list shall be published at the latest on the Friday before the week of the Competition.

6. REGISTRATION PLATFORM

All registrations will be processed via the FIA TCR World Ranking Final registration platform, which can be accessed via the following link:

7. REQUIRED DOCUMENTS

The following documents will be collected via the FIA registration platform.

Only complete applications submitted through the registration system will be reviewed.

- For each driver:
 - Valid 2025 international license
 - Valid 2025 Medical Certificate of aptitude (either present on the license "apt to practice motorsport" or confirmed via a separate medical certificate with the doctor's signature, stamp and date)
 - Starting permission from the driver's ASN allowing the driver to take part in the event (either present on the license or presented in a separate official letter)
 - 2025 FIA Driver Medical Form
- For each competitor:
 - Valid 2025 international license
- Proof of entry fee payment

ON-SITE IN VALLELUNGA:

- For each driver:
 - FIA Driver Declaration signed with ink signature

The FIA reserves the right to collect other documents, such as driver photos, car liveries, etc., throughout and following the completion of the registration process.





8. ENTRY FEES

The entry fee per competitor is 5,000 euros per car.

The payment will be collected during the registration. Payments can be made by credit card or bank transfer.

Please note that the billing address submitted in the online registration form will be used for invoicing.

Invoices for <u>fines</u> issued during the event by the stewards will be addressed to the same billing address.
