REGULATIONS

The final text of these Supplementary Regulations shall be the English version which will be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

Article 4 - Insurances

In compliance with the legal prescriptions, the Organiser has contracted one or several insurance(s) guaranteeing the following risk(s):

Liability insurance:

EUR 5 Mio for physical injuries per claim, however no more than

EUR 3,0 Mio for an individual person EUR 1,1 Mio for consequential losses

The insurance covers the legal liability.

Article 5 - Protests and Appeals

The protest fee is €1,000.00

The appeal fee set by the ASN is € 1,500.00

The international appeal fee (FIA) is € 6,000.00

All protests will be lodged in accordance with the Code. All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards of the Competition, together with the required protest fee.

If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit of $\leqslant 5.000$

Competitors have the right to appeal, as laid down in Articles 14.2, 14.3 and 14.4 of the Code and also as set out in the Rules of the International Court of Appeal.

Article 7 - Event supplementary provisions

Drivers may refuel only in the Refuelling Zone (RZ), designated for that purpose. During refueling operations, they must follow the instructions of the fuel supplier and of the staff monitoring the RZ.
