## **REGULATIONS**

The final text of these Supplementary Regulations shall be the English version which will be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

#### Article 4 - Insurances

In compliance with the legal prescriptions, the Organiser has contracted one or several insurance(s) guaranteeing the following risk(s):

GP3R affects a Master Insurance Policy in respect of third party public liability risks to a level of 5 million dollars CDN for any one accident.

#### Article 5 - Protests and Appeals

The Protest fee is CDN \$2,000 payable to ASN Canada FIA.

The Appeal fee is CDN \$2,500 payable to ASN Canada FIA.

The international appeal fee (FIA) is €6,000.

All protests will be lodged in accordance with the Code. All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards of the Competition, together with the required protest fee.

If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit of CDN \$3,000 payable to ASN Canada FIA.

Competitors have the right to appeal, as laid down in Articles 14.2, 14.3 and 14.4 of the Code and also as set out in the Rules of the International Court of Appeal
