REGISTRATION AND ENTRY PROCEDURE

Dear Competitors,

We are pleased to inform you that:

1. The Sporting Regulations and the Calendar of the 2014 FIA F3 European Championship will be available from 5 December 2013 on the website www.fia.com or via the following link:

2. Competitors applications consist of two steps:

- I. **The pro forma entry form** will be available on the FIA website (<http://www.fia.com/championship/formula-3/2013/fia-formula-3>) from **Thursday, 5 December 2013**. You may apply to enter after reading the conditions for entry described in the applicable sporting regulations.

"Season" competitors' pro forma entry:

- ➔ Closing date: **20 December 2013, midnight.**
- ➔ Entry fee: 500 euros per car entered.

Entry applications will only be considered if the team intending to enter the Championship has applied using the pro forma entry form respecting the above mentioned deadline.

- II. **The online entry form** (<http://www.fia.com/sport/competitors-area/forms>) will be available from **Wednesday, 1 January 2014**.

a) "Season" competitors' entries:

- ➔ Closing date: **28 February 2014, midnight.**
- ➔ Entry fees: 12,000 euros per car per season;
6,000 euros per driver per season.

b) "Race-by-race" competitors' entries:

- ➔ Closing date: **14 days prior to the start of the event in question.**
- ➔ Entry fees: 3,000 euros per car per event;
2,000 euros per driver per event.

Attachments which must IMPERATIVELY accompany the entry application:

- a copy of the competitor's licence issued by the respective ASN
- a copy of the driver's licence
- a copy of the bank transfer corresponding to the total amount of the entry fee required
