**Decision** Deletion of the lap time shown as advised in the Event Notes.

**Reason** The Stewards reviewed video and received timing information from the Race Director. The cars left the track. The penalty was applied in accordance with point 20 of the Race Director's Event Notes and Article 12.1.1 (i) of the FIA International Sporting Code.
