Decision Deletion of the lap times shown in accordance with Article 12.4.1.e of the FIA International Sporting Code and Article 31.4 of the FIA Formula One Sporting Regulations.

Reason The Stewards reviewed video and received timing information from the Race Director. The cars left the track. The penalty was applied in accordance with point 21 of the Race Director's Event Notes (reference Article 12.2.1.i) and Article 12.4.1.e of the FIA International Sporting Code.
