**Decision** Deletion of the lap time shown in accordance with Article 12.4.1.e of the FIA International Sporting Code.

**Reason** The Stewards received timing information from the Race Director. The cars failed to negotiate the turns above using the track. The penalty was applied in accordance with Article 12.4.1.e of the FIA International Sporting Code as advised by the Race Director Event Notes item 18.1.
