Note 1: Decision 7 & 8 - Car 1 was off track a two different turns on the same lap, 1:31.275. Car 1 was off track & continued, this does not count as a track limit violation, but the lap time was nevertheless deleted.

Offence Breach of Appendix L, Chapter IV, Article 2c of the FIA International Sporting Code and Article 27.3 of the FIA F2 Sporting Regulations.

Decision Deletion of the lap times shown in accordance with Article 12.4.1.e of the FIA International Sporting Code.

Reason The Stewards received timing information from the Race Director. The cars left the track. The penalty was applied in accordance with Article 12.4.1.e of the FIA International Sporting Code as advised by the item 19.2 of the Race Director's Event Notes.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.

Decisions of the Stewards are taken independently of the FIA and are based solely on the relevant regulations, guidelines and evidence presented.
