### **Technical Delegate's Report**

#### **During the qualifying session:**

All cars had their tyre codes recorded and were checked for the correct allocation.

#### After the qualifying session:

The following cars were weighed

All the above cars were checked for:

- 1) Front and rear wing width and height.
- 2) Under floor height.
- 3) Rear diffuser height.
- 4) Wheel camber conformity.
- 5) Rear wing gurney conformity.

The skid planks were checked for thickness and nomination on car numbers 2, 4 and 23.

The steering rack, rack stop, housing and pinion were checked for conformity on car numbers **2**, **4** and **23**. The oil catch tank was checked for conformity on car numbers **2**, **4** and **23**.

The front right ackerman, track rod and camber shims were checked for conformity on car numbers **2**, **4** and **23**.

The engine ECU was checked for conformity on car numbers 2, 3, 4, 12, 23 and 31. The gearbox gear ratios were checked for conformity on car numbers 2, 3, 4, 12, 23 and 31.

The tyre pressures were checked for conformity on car numbers **2**, **3**, **4**, **12**, **23** and **31**. Fuel samples were taken from cars number **12** and **31**.

The fuel samples were checked for density and analysed by gas chromatography.

The result of the fuel analysis shows that the fuel was the same as the one, which has been supplied by the official supplier at the event.

All cars had their tyre codes recorded and were checked for the correct allocation. All driver weights have been recorded.

All the above items and car weights were found to be in conformity with the requirements of the 2024 Formula 3 Championship Regulations.
