**Offence** Breach of Appendix L, Chapter IV, Article 2c and 12.2.1.i of the FIA International Sporting Code, failure to follow the Race Director's Event Notes 18.3 (a)

**Decision** Deletion of the lap times shown in accordance with Article 12.2.1.i of the FIA International Sporting Code. Deletion of the lap the infringement took place, and the following lap.
