Technical Report

Before the race:

The following parts have been replaced today after 13:55 and before the start of the race:

Sauber Ferrari:

Car 12: Front wing / FIS assembly

Marussia Cosworth:

Car 23: LHS and RHS FIS cam locks

A front wing deflection test was carried out on car numbers 01, 04 and 22.

A fuel sample was taken from car numbers 04, 09 and 22 and analysed during the race.

On the grid it was checked that all cars had fitted their tyres when the 3-Minutes board was shown.

After the race:

The steering wheel of all classified cars has been checked.

Car numbers 08, 14, 15 and 19 were checked for the following:

- 1) Bodywork around the front wheels
- 2) Front wing height and overhang
- 3) Rear wing height and overhang
- 4) Front and rear wing width
- 5) Rear wing configuration
- 6) Rear bodywork area
- 7) Rear winglet height
- 8) Skidblock thickness
- 9) Stepped bottom
- 10) Diffuser height
- 11) Diffuser area
- 12) Overall height
- 13) Overall width

The profile of the prescribed front wing section in Article 3.7.3 of the 2013 Formula One Technical Regulations was checked on car numbers 08, 14, 15 and 19.

The minimum distance between the adjacent rear wing sections at any longitudinal vertical plane was checked on car numbers 08, 14, 15 and 19.

It was confirmed for car numbers 08, 14, 15 and 19 that any vertical cross section of bodywork normal to the car centre line and situated in the volumes defined in Article 3.8.4 form one tangent continuous curve on its external surface with a radius no less than 75mm.

The concave radius of sections of the three rear wing elements which are in contact with the external air stream was checked on car numbers 08, 14, 15 and 19.

The front and rear brake air duct dimensions were checked on car numbers 08, 14 and 15.

It was confirmed for car numbers 03, 07, 08, 14 and 15 that a one litre sample of fuel could be taken

after the race.

It was confirmed for car numbers 01, 05 and 06 that the minimum weight of 642 kg was respected at all times during the race.

It was checked that no classified car exceeded 80 km/h when leaving the formation grid prior to the start of the race.

The units locking status was checked on all cars.

The session type has been confirmed for all cars.

Software version checks have been carried out on all cars.

Chassis FIA checksum was checked on all cars taking part in the race.

The start data of car numbers 04, 07 and 08 have been checked.

The uppermost rear wing element's adjustable positions were checked on car numbers 01 and 08.

The base ignition map range was checked on all cars.

The cylinder ignition offsets range was checked on all cars.

It was checked that car numbers 01, 04, 06, 08 and 09 did not exceed 18000 rpm during the race.

The fuel pressure of car numbers 01, 04, 06, 08 and 09 during the race was checked.

The logged pressure within the engine cooling system during the race was checked on car numbers 01, 04, 06, 08 and 09.

The tyres used by all drivers during the sessions today have been checked.

A fuel sample was taken from car numbers 06 and 14.

The fuel samples have been checked for density and analysed by gas chromatography.

The results of all the fuel analyses show that the fuels were the same as ones, which had been approved for use by the relevant competitors prior to the Event.

All car weights and the items checked were found to be in conformity with the 2013 FIA Formula One Technical Regulations.
