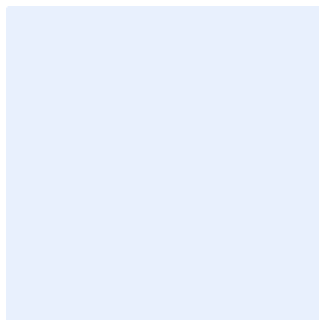

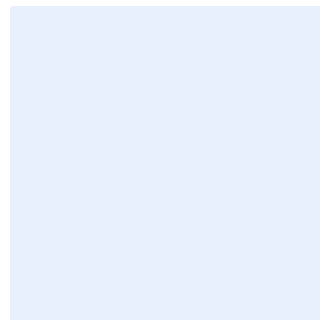

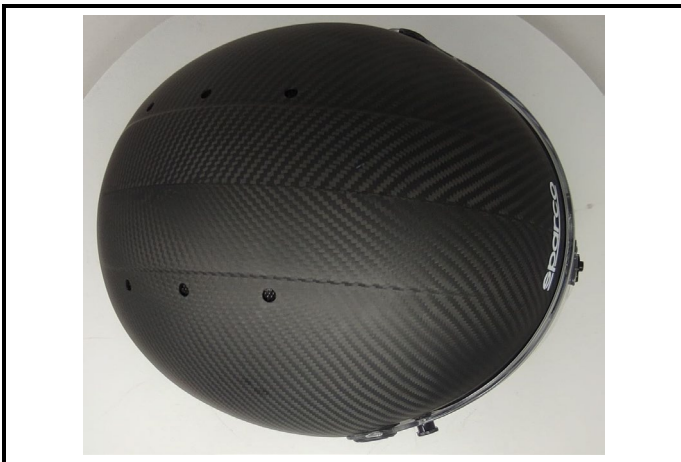
D1) Vue de face / Front view
