NISH SHETTY FIA STEWARD AND MEMBER OF THE FIA INTERNATIONAL COURT OF APPEAL

Nish Shetty sits on the FIA International Court of Appeal as a judge and is a permanent member of the National Court of Appeal (Singapore). He is also Chairman of the Disciplinary Commission of the Singapore Motor Sports Association and a national steward of the Singapore Grand Prix. Shetty has assisted the Association for many years as a legal advisor and committee member. In addition to being involved in the Singapore Grand Prix, Shetty has acted as a steward in the Singapore Karting Championship. Away from motor sport, he is a Partner and Head of International Arbitration and Dispute Resolution, South East Asia at global law firm Clifford Chance.

LOÏC BACQUELAINEFIA FORMULA 1 STEWARD, FORMULA 3 STEWARD

Born in the Ardennes near the famous Circuit de Spa-Francorchamps, Loïc Bacquelaine has been involved in motor sport from an early age. He works in Luxembourg in the legal profession, specialising in financial law. Alongside his role as a steward in FIA Formula 1 and Formula 3, he has also worked as a steward across a wide range of international motorsport classes, including the Porsche Supercup, TCR, Le Mans Cup and Porsche GT Cup.





ENRIQUE BERNOLDI

FORMER FORMULA 1 DRIVER, CHAMP CAR, INDYCAR, WEC AND FIA GT1 DRIVER

Brazilian driver Enrique Bernoldi had a stellar junior career, winning the Formula Renault Europe title in 1996, before twice finishing on the podium in Macau, and runner-up in the 1998 British F3 Championship. He combined F3000 with a stint as a Sauber test driver in 1999 and 2000, before making his F1 debut with Arrows in 2001. He made 29 appearances for Arrows over the next season and a half, with a best result of eighth. He followed this with spells as a test driver for BAR and Honda, then moved on to US open-wheel racing, Brazilian stock cars and sportscars.

CHRISTOPHER MCMAHON

NATIONAL STEWARD

After beginning his motor sport career in 2003, Chris McMahon advanced from officiating at state-level events to become a member of the permanent panel of Stewards for the Australian Supercars Championship in 2013 and has been co-chair of the panel since 2015. Between 2016 and 2019, he acted as ASN Steward for FIA WRC Rally Australia and continues to officiate at a number of WRC rounds. During 2018 and 2019 he participated in the FIA's International Stewards Program. Chris has also acted as the Chair of Motorsport Australia's Judicial Advisory Committee since 2017, is a member of Motorsport Australia's Queensland Officials Advisory Panel and is a member of Motorsport Australia's Queensland State Council Executive.
