## a) Cost of entry per Season:

21,500 € per car for the Super 2000 category (TC2 Turbo, TC2, TCN2 and TCN)

• 18,800 € per car for the Single Make Cups category

• 9,400 € per car for the Super 1600 category

Closing date: 16 March 2016, midday

## b) Cost of "Race-by-race" entries:

• 4,700 € per Event per car for the Super 2000 category (TC2 Turbo, TC2, TCN2 and

TCN)

4,350 € per Event per car for the Single Make Cups category
2,170 € per Event per car for the Super 1600 category

Closing date: 14 days prior to the beginning of the event.

- a copy of the competitor's licence issued by the ASN
- a copy of the driver's licence
- a copy of the first page of the homologation form of the car, as issued by the ASN or the (featuring the homologation number)
- a certificate from the ASN concerned proving that the car conforms to the national technical regulations
- a copy of the bank transfer voucher corresponding to the amount of the entry fees required



# **NOTE**

We would like to draw your attention to entering the correct **billing address** at the time of entry form inscription. This billing address will be used throughout the whole season for completing and sending any invoices for the payments related to your entry. Please note that the fine payments will be invoiced to the same billing address.

We would like to draw to your attention to informing the FIA administration in any case of changes (driver change, withdrawal, etc.) of your entrant 48 hours before the beginning of every competition in question. Any changes after this deadline will be reported to the Panel of Stewards for it to take into consideration.
