- a color copy of the competitor's (and/or manufacturer's) licence issued by your ASN
- a color copy of the driver's licence
- a copy of the 1st page of the FIA Homologation Form of the car (on which the homologation number appears)
- for competitors registered under Articles 10b) <u>only</u>: a certificate from the ASN concerned, proving that the car is in conformity with the national technical regulations and a copy of the first page of the homologation form of the car issued by the ASN (on which the homologation number appears)
 a copy of the bank transfer corresponding to the total amount of the entry fee required

<u>NOTE</u>

We would like to draw your attention to entering the correct **billing address** at the time of entry form inscription. This billing address will be used throughout the whole season for completing and sending any invoices for the payments related to your entry. Please note that the fine payments will be invoiced to the same billing address.

We would like to draw to your attention to informing the FIA administration in any case of changes (driver change, withdrawal, etc.) of your entrant 48 hours before the beginning of every competition in question. Any changes after this deadline will be reported to the Panel of Stewards for it to take into consideration.
