<sup>12.13.2</sup> If, however, the ASN wishes the sentence of Suspension against any of its licence-holders (Competitors, Drivers, officials, Organisers, etc) to be recognised internationally, it shall notify its wish without delay to the Secretariat of the FIA and the latter will inform all other ASNs. The sentence of Suspension shall be noted by each ASN immediately, and the consequent restriction will thereby come into force.

It shall be notified to all the ASNs and be registered by them according to the conditions of international Suspension."
